REL Southeast Governing Board meets to discuss new work, partnerships

REL Southeast convened its first Governing Board meeting of the 2022-27 contract cycle on Sunday, March 6 and Monday, Mach 7. Priorities for the new cycle were discussed, including the relevant and rigorous implementation of research and practice, working in partnership with stakeholders to dive deeper to improve student achievement, and centering equity in how and with whom we do our work.

The two-day event kicked-off with a keynote presentation on implementation science by Dr. Caryn Ward from the University of North Carolina at Chapel Hill. Monday, the board was briefed on proposed projects and introduced to the recently formed partnerships that will drive the work of REL Southeast. The partnerships include:

The Governing Board also discussed plans to create a new educator toolkit during the 2022-27 cycle. The toolkit will be developed around the What Works Clearinghouse practice guide, <u>Assisting</u> Students Struggling with Reading: Response to Intervention (RtI) and Multi-Tier Intervention in <u>Primary Grades</u>, and will specifically focus on the guide's second recommendation to provide differentiated reading instruction for all students based on assessments of students' current reading levels.
